 - Sexual misconduct with a minor as a *Class A or Class B Felony* (IC 35-42-4-9)
 - Incest (IC 35-46-1-3), if the victim is less than eighteen (18) years of age

Any person who uses Limited ADULT Criminal History for any purpose not specified in the request commits a Class A Misdemeanor offense as defined under IC 10-13-3-27.
